“Vending Operator” hereby employs Top Notch Locating to provide the following location services. Top Notch Locating is an independent vending locating service whose sole purpose is for locating and securing coin-op vending machine locations. Top Notch Locating does not guarantee profits at secured locations. This contract is valid in Los Angeles County, California. Jurisdiction of any dispute between the Vending Operator and Top Notch Locating shall be in Los Angeles County, California.

### “Vending Guarantees”

First Right of Refusal: Vending Operator gets to Check Out the location (but not place the Machine) and if the location is not desired we will replace the location at no cost to the operator. Once the machine is placed, that location is the Vending Operators and not subject to replacement.

35 Day Guarantee (Bulk Only): (includes First Right of Refusal) Once Vending Operator places the machine at the secured location, they have a 35 day Guarantee on that Location. Replacement locations do not restart the timeframe of the guaranteed locations.

Only 20% of the Total amount of locations contracted can be returned for replacements (Bulk Only). Locations that refuse equipment will be relocated free of charge. Any location that is lost due to Untimely machine Placement and/or vendor fails to service properly will not be subject to replacement. Any dishonest or fraudulent activity voids the “Vending Guarantee”. Payment must be received before assigning re-locations. “Vending Guarantee” refers to re-locating of equipment and all fees made pursuant to this agreement are non-refundable.

### “Canceling the Contract”

There is a 20% service charge for all canceled contracts. Canceled contracts must be received in writing.
